

General Terms and Conditions (GTC) of the Eglisau Triathlon

1. Data collection and data use of the organizer

- A. The personal data provided by participants upon registration will be stored and processed for the purpose of implementing and managing the event. This includes the transfer to contracted service providers and medical services. With the registration the participating person agrees to the storage of the data for this purpose.
- B. The participating person agrees to the transfer of his/her personal data for the purpose of sending photos of the participants and the event.
- C. The photos, film recordings and interviews of the participants taken in connection with participation in the event may be distributed, processed and published by the organizers on radio, television, print media, the Internet, books, reproductions (analog or digital films, digital data carriers, etc.) without any claim to remuneration.
- D. Personal data of the participant will be printed or published for the presentation of result lists in all relevant media accompanying the event. With the registration the participating person agrees to the storage, publication and utilization of the personal data for this purpose.
- E. During the event, personal data of the participating person will be published on the Internet for verification and presentation of the current registration status. By registering for the event, the participating person consents to the storage, publication and utilization of the personal data.

2. Liability

- A. The organizer is not liable for accidents, damages and thefts.
- B. The athletes undertake to comply with the regulations of the organizer according to the announcement.
- C. Physical fitness to participate in the competition is the responsibility of the participating person.
- D. The participants are aware that participation in a competition involves dangers and that the risk of serious injuries or even fatal accidents cannot be completely excluded.
- E. Participants agree that during the event and related activities, personal property and athletic equipment are the sole responsibility of the participants.
- F. Participants agree that registration data may be made known to third parties through the dissemination of ranking lists and the like.
- G. The participants agree that image and sound rights for photos, film recordings, interviews etc. can be transferred to the organizer or the companies or sponsors commissioned in connection with the event - without any claim to remuneration. The data may be used for advertising purposes.
- H. The participants agree that e-mail addresses will be used for the regular newsletter mailing with information about our offers. This data will not be passed on to third parties.

- I. Participants and subscribers of the newsletter agree that the stored contact information will be used for sending the newsletter and further information.
- J. The participants indemnify the organizers, the organizers and the helpers of the Eglisau Triathlon from all liability claims, unless these are covered by the legal liability. This includes all direct and indirect damages, as well as all claims which the participants or their heirs or other entitled third parties may assert due to injuries suffered or in the event of death. The participants indemnify the organizer from the assumption of damages, as far as these damages have arisen as a result of participation in the Eglisau Triathlon.
- K. The participants are aware of the fact that the entry fees can be increased step by step. The participants are aware that if the event cannot take place or can only take place in a modified form due to force majeure or official requirements, there is no right to a refund of the entry fee.
- L. The participants agree that a possible price difference will not be credited to a category change. The organizer reserves the right to make exceptions.
